



## Policies & Membership Guidelines

To participate as a PINK MILLIONAIRE Club Member, you must agree to the following:

This Membership Agreement ("Agreement") contains the complete terms and conditions between us, Pink Millionaire Club and you regarding your participation as a Pink Millionaire Core or Diamond Member.

PINK MILLIONAIRE Club (PMC) is a division of Success Strategic Partners, a wholly-owned Limited Liability Corporation in the state of Georgia and not associated or affiliated with any other membership company, network marketing company, mlm company or franchise.

### 3. Refund Policy

**Membership Refunds:** As a member you understand that there are no refunds for membership fees paid to PMC. Upon payment, you automatically are given full access and privileges to your chosen membership benefits.

**Event Refunds:** Should PMC schedule an event that is cancelled or postponed, members upon request can be given a full no-penalty refund. In cases where the member is asking for a full refund without justification, an administrative service fee (rates will vary) shall be charged.

PMC Core Members are known as “Pink Millies” and our PMC Diamond Club Members are known as “Pink Diamonds” or “Gems”. We often refer to the different member levels by these name references in emails, posting in social media and during live events. As a member, you understand that you may not at any time freely use the words, PINK MILLIONAIRE, PINK MILLIONAIRE CLUB, PINK Millie, PINK Diamonds, PINK Gems or PINK MILLIONAIRE DIAMOND CLUB for personal use in your own business, business idea(s) or any content for any purpose **other than to refer to the club in which you belong.**
